

- C. Area of Operation ALL OVER INDIA
- D. That the objects for which this trust is established are
 - To open, establish and manage collages, institutes, universities and Hostels of technical and non technical, Professional education streams for higher education like engineering, medical, Arts, Design, Management, Research, Music, Dance, Culture and sports etc. so that the poor students may succeed in their life and contribute to nation's overall development.



- k. The registered office or the principal place of activity of the applicant should not be transferred outside the jurisdiction of Jurisdictional Commissioner of Income Tax except with the prior approval.

SKILL TRAINING PROGRAME

Pavitra Hriday, highlights an initiative aimed at fostering entrepreneurship skills among students. A virtual online training programme, consisting of a practical and intensive 15-day Entrepreneurship Skill-Training Workshop, was organized free of cost. The programme provided a framework for developing and scaling ideas, which included idea generation, validation, development, and real-world testing.

The training programme was designed inspire and educate young entrepreneurs, equipping them with critical skills to address community create sustainable and issues this enterprises. To end, the programme included technology to market accelerators, business plan competitions, ideation workshops, technology tools, and entrepreneurship curricula to help students build entrepreneurship skills.



The e-learning course, which covered the fundamentals of entrepreneurship and basic technology tools for empowering businesses, was 40 hours long and provided entrepreneurship education to commercialize and scale businesses. After successfully completing the programme, 25 students made a final presentation using technology for entrepreneurship.

Overall, the programme was a success in bringing about awareness of entrepreneurship skills among students in distt. Alwar Rajasthan, providing education and critical skills, and empowering them to address community issues through sustainable enterprises.




