# Welfare & Developmental Activities of the Organisation

1. Program to support children in Difficult circumstances including Street and Working Children of NCR and Banjara Basti of Dhaba Complex in City Council Area Bhiwadi

we are conducting non formal education program where We are identifying them and arranging for imparting them reading and writing skill. The aim of this school is to provide education to the children who are not in a position to attend any formal school and to help them grow into responsible adults and to encourage them becoming independent.

There are several children of poor families who are leftover on the streets and nobody take care of their health. Some of these children tend to look to the other side of life i.e. they get involved in various criminal activities and end up as antisocial elements.

As per observation and the feedback from the local people we found that most adult illiterates spend most of their time making a livelihood. So it was necessary to adjust the timing of this program according to their need and suitability. So designed the program accordingly and implementing successfully.

Our volunteers and social workers identify the needy ones and help them get immediate relief from child line and if needed we refer these cases to orphanages.

#### 4. Vocational education & Entrepreneurship Development Programs:

To bring about awareness about entrepreneurship skills a 15 days virtual online

training programme was organized for students free of cost. The Entrepreneurship Skill-Training Workshop was a practical and intensive 15 days program which trained the participants on a process for developing and scaling ideas. The program consisted of an ideas framework that helped participants, get ideas, validate them, develop them and test them in a real world environment.

The programme was aimed at inspiring and providing education and critical skills for young entrepreneurs and designed to give prospective entrepreneurs the skills and resources they need to address community issues and create sustainable enterprises. These programs include technology to market accelerators, business plan competitions, ideation workshops, technology tools, entrepreneurship curricula to help students build entrepreneurship skills. The e-learning course was based on the fundamentals of entrepreneurship and education on basic technology tools that can be used to empower businesses. The program had 40 hours of content and gave entrepreneurship education to commercialize and scale businesses.

After successful completion of the programme the students made a final presentation with the use of technology for entrepreneurship. 25 students successfully completed the training programme.

In this front we are organizing Mahila Mandals and Mahila Panchayats in these villages where our women volunteers discuss the issues and try to settle the matter immediately with the consent of family members.

### 9. blood Donation camps, Health promotions and covid Awareness

Following a call by the district authorities, our NGO has taken up campaigns to create awareness among the public on the importance of using sanitisers, wearing masks and maintaining physical distance to protect oneself from coronavirus.

This year we organized one blood donation camp in association with local hospitals. In the program many dignitaries too participated and contributed in the campaign. Youths and volunteer donated blood and nominated their availability for emergency cases where it requires, they can further donate blood.

#### 10. Environmental Awareness Programs

The basic objective of the program was to ensure Participation of School Children virtually and getting them involved in environmental protection and awareness campaign. 2 schools of the community are working with us and contributing for the cause of environment protection programs. This year we held 4 inter school essay writing competition and painting competition based on environmental themes. Simultaneously a plantation drive too was launched with a target of panting at least 1000 shrubs and trees in a barren land.
